


Review the following Options Configuration settings and Security Bits <u>prior</u> to using **Returns Validation**.

Choose 'Returns Validation' in the **Options Group** and press 'Enter' to populate the grid. 20 Options will display. Review them in addition to these 4 options: **5494, 9431, 9434 and 9831**. A full list of all 24 Options is provided on the next page. *All* of these must be reviewed and set prior to using Returns Validation.



## Epicor Eagle Software Release 25.1 and Higher

The following <u>Directed Refunds Enhancement</u> is available on Eagle Software *Release 25.1 and higher*. Transactions and Deposits paid by 'A/R Charge' and 'Debit Cards' can now direct the clerk to refund the amount back to the original form of tender.


The following **Returns Validation Enhancement** is available on Eagle Software **Release 25.1** and **higher**.

If your return policy allows returns without receipt or the original credit card, then the new **Options ID 9829 'Prompt for Drivers License on return w/o original receipt/credit card'** may be very helpful. The main intent for this feature is to alert the store of potential fraudulent return patterns where a customer is attempting to return stolen merchandise.

The clerk will be prompted to request the customer's driver's license. If they decline a manager override is required to continue with the return. Otherwise, once the DL has been scanned (or manually entered) it will be recorded on that return in the Customer Returns Viewer.


The report **RCEM** (Customer Returns Eligibility Report) should be added to a daily queue. This will tally the 'number of times within XX days' a Driver's License was required for a no-receipt return. RCEM will also generate an alert for each Drivers License it flags as 'Not eligible for returns'.

- If that number is one less than the 'max allowed within XX days', that DL will be flagged as 'Almost ineligible for returns'.
- If that number is equal to or greater than the 'max allowed within XX days', that DL will be flagged as 'Not eligible for returns'.






The 'Customer Returns Viewer' has a new option under the 'Miscellaneous Menu': 'Driver's License Maintenance'. Here you can manually change a DL's 'Eligible for Returns?' flag.



Customer Returns Viewer also has the new lookup 'Driver's License Number' used to see the list of no-receipt returns where the customer submitted their Driver's License.



These columns have also been added to this viewer: 'DL Eligibility for No Receipt Returns', 'Driver's License Date Added', 'Driver's License Last Updated'.



If you are using **Flexible Consumer Information** (option 1498=Yes) and currently have it configured to collect consumer information for 'Totaling transaction with a return' you should **remove** Driver's License from the list of fields which appear for a return. Otherwise a Driver's License entered for a return 'with receipt' or 'with original credit card' cannot be distinguished from a one collected for a 'no receipt' return.
