## Setting Up In Store Gift Cards Options

There are 16 settings in Options Configuration that must be addressed prior to using In Store Gift Cards. Please review each before processing your cards at Point of Sale.

To isolate these you can simply type **OPTGC** in the Launch bar, and press Enter.

Options ID# 5473: 'Gift/Cash Card on System'

Options ID# 9070: 'In-Store Gift Card on System'

The MSY flag for these two options must be set to 'Yes' in order for the In Store Gift Card application to work. The Epicor Financial Services Group will update this setting after purchasing this application. Contact your Customer Account Manager with any questions.

**Options ID# 3336:** 'Record "Gift card activation" alerts', determines whether or not you want the system to generate an alert when a gift card is activated at POS. This option defaults to Y.

**Options ID# 4905:** 'Print a store copy receipt for bankcards'. Set this option to 'Yes' if you want to print a 'merchant' or store copy for Gift Card activations, add funds, void add funds, and cash-outs.

**Options ID# 5126:** 'Use card bin ranges to determine credit/debit/gift card type ' should be set to 'Yes'.

**Options ID# 5360:** 'Gift/Cash card type' should indicate which program you are using. Contact your Customer Account Manager if you are unsure.

**Options ID# 5364:** 'Gift/Cash Card activation minimum amount'. This option determines the minimum issue amount for a sold or activated gift card. When

using option 5980, 'Force Gift/Cash Card activation', this is the minimum amount a gift card SKU can be sold for.

**Options ID# 5366:** 'Gift/Cash Card activation maximum amount'. This option determines the maximum issue amount for a sold or activated gift card. When using option 5980, 'Force Gift/Cash Card activation', this is the maximum amount a gift card SKU can be sold for.

**Options ID# 5368:** 'Gift/Cash Card cash-out maximum without M/O'. This option determines the maximum amount of a cash-out of a Gift Card without requiring a manager's override. If you always require a manager's override for a cash-out, enter 0. If you never want to require a manager's override, enter 99999.99.

**Options ID# 5980:** 'Force Gift/Cash Card activation'. Epicor recommends you set this option to 'Yes', so that your clerks are forced through the activation process when they sell a gift card, and, conversely, so that a gift card cannot be activated without first selling and taking payment for it.

**Options ID# 5981:** 'Gift/Cash Card - print amount remaining on POS receipts/invoices'. This option only applies if the option 'Gift/Cash card type' (ID# 5360) is set to A = Wildcat (Ace). Set this option to 'Yes' if you want the amount remaining on the card to print on the receipt or invoice on transactions with payment by Gift Card. Set this option to No if you do not want the amount remaining to print.

**Options ID# 5982:** 'Record "Gift Card Activation aborted" alert'. Set this option to 'Yes' if you want the system to record an alert if the automatic gift card activation process is aborted. This activation process occurs for each gift card sold in a sale. This process can only be aborted if the clerk or a manager doing an override has security bit 758.

**Options ID# 7302:** 'Days to keep completed In-Store gift card records' Enter the minimum number of days to keep In Store Gift Card records that are marked as completed.

**Options ID# 9071:** 'In-Store Gift Card Surcharge Amount'. This option allows you to determine a surcharge fee for inactive cards. Check with local and state laws before enabling.

**Options ID# 9072:** 'Number of days inactive before assessing gift card fees'. The number of days a gift card is inactive before being assessed a surcharge. The system date is compared to the last date used to identify inactivity. Check with local and state laws before enabling.

**Options ID# 9076:** 'In-Store Gift Card description for receipts'. Only applies to customers who use both In Store Gift Cards and a National Account card such as ACE, True Value, DIB or Rona. This is the description that will print on the receipt when they pay for a purchase with the In Store Gift Card. Payment with a National Account gift card will use the description of the Alternate Tender whose Type is set to G.
